Current Faculty Membership and Leadership Positions in Senate and FDA

1. Faculty seats in the Senate Assembly (HCGC, Article III, Section 1)

- Senators elected by departments from titles: Professors, Associate Professors, Assistant Professors, Instructors on full-time appointments, and Lecturers on full-time appointments. All departments have two Alternates.
- 12* Senators nominated by departments from titles: Lecturers (part-time), Adjunct faculty, all other part-time members of the teaching faculty who are not also serving in full-time appointments, Clinical Professors, Distinguished Lecturers, and non-faculty department members in the title series College Laboratory Technician and Higher Education Officer.

[*by HCGC, Art IV.2.B.i, the 13th seat to make up the "57% faculty" requirement of Art III, Section 1 is reserved for Student Services]

Currently, Hunter has 35 departments:

For full-time tenure-track, CCE-line faculty, and instructors:

9 have 2 Senators + 2 alternates = (18+18) = 36 faculty

26 have 1 Senator + 2 alternates = (26+52) = 78 faculty

Subtotal: 114 faculty

For part-time faculty, including Adjunct faculty, full- or part-time Distinguished Lecturers and Clinical Professors: at most 12

So, total number of faculty members of the Senate in a given year are 114 – 126.

2. Faculty positions in the Senate Administrative Committee (HCGC, Article V):

From Officers of the Senate – at least 1 and at most 2 (Vice Chair must be a student):

Chair, shall be a full-time faculty with tenure or CCE.

Secretary, shall be elected from voting membership

Four at-large members, shall be elected from voting membership – at most 4 faculty

3. FDA Membership by Bylaws of the General Faculty (Article IV.1):

- A. Two members elected by each department [currently 35 departments, 70 faculty]
- B. Those members of the Administrative Committee of the Hunter College Senate who are faculty members, serving ex officio with vote. [currently 5 members of the SAC are faculty]
- C. All Hunter college delegates to the university Faculty senate serving ex officio with vote. [13]
- D. The members of the Executive Committee of the GF serving ex officio, with vote. [7]

So total current membership of FDA: 95

4. FDA Executive Committee by Bylaws of GF (Article III) – 7 members

III.1 The officers [of the GF] shall be a President, a Vice-President, a Secretary, a Treasurer, and three members elected at-large: one whose primary teaching responsibilities are in the day; one whose primary teaching responsibilities are in the evening; one who is a member of the part-time teaching faculty.

III.2 These officers shall constitute the Executive Committee of the General Faculty and the Executive Committee of the Faculty Delegate Assembly.
