## **Professional Licensure Disclosures**

Effective July 1, 2024, federal regulation requires institutions of higher education to make a determination whether a Title IV eligible academic program that leads to professional licensure or certification meets the educational requirements for licensure/certification in the U.S. state where the institution is located and the U.S. states where "distance education" students are

located at the time of initial enrollment in the program, as well as U.S. states where the program is advertised as meeting such requirements, and if applicable, the U.S. state where students attest they intend to be licensed/certified.

The professional licensure programs listed below are registered by the New York State Education Department and thus meet the educational requirements for licensure/certification for New York State. Through a good faith effort, and for the purpose of complying with the federal regulation, we have determined that these programs either meet or do not meet the educational requirements for licensure/certification in certain other U.S. states.

It is important to note that the Hunter-Bellevue School of Nursing is not the licensure/certification authority in these U.S. states and cannot assess whether an individual candidate will be issued a license/certificate in these U.S. states. Instead, it is incumbent on each individual candidate to contact the licensure/certification authority in the applicable U.S. state for any further guidance on the requirements for licensure/certification requirements and application processes.
